



School Council Constitution 2019/2020

Councillors and their behaviour and attitude

- The council shall be made up of two representatives from each class, one boy and one girl from Year 2 to Year 6.
- A councillor, once elected, will be on the School Council for one school year.
- A councillor is expected to behave in a supportive way and with a positive attitude towards the other councillors and all other people.
- A councillor works hard to make the School Council and the decisions it makes as successful as possible for the school.

Voting and selection procedures

- All decisions taken at School Council meetings shall be by a show of hands or secret ballot, with votes for and against recorded.
- If a vote is a tie, the chairperson will have the deciding vote.
- The link teacher and/or head teacher can vote in School Council meetings.
- The chairperson will be elected by the councillors.
- The secretary will be decided by a vote by all the councillors.
- School Councillors stay on Green. If a pupil has more than two BCF entries in a school year, they will no longer be able to represent their class as a School Councillor for the remaining academic year.
- School Councillors have excellent attendance levels of 96% or above. If attendance falls below 96%, they will no longer be able to represent their class as a School Councillor for the remaining academic year (excluding any religious authorised absences).
- A letter be sent to all School Councillors giving their individual attendance for that Term.
- A Councillor can only be elected 2 consecutive academic years.

Structures and procedures at School Council meetings

- School council meetings will be held at least once every half term.
- Meetings will only take place when the link teacher and/or head teacher is present.
- The agenda will be decided in advance by the link teacher, chairperson, and the secretary.
- The council must make sure that all people likely to be affected by a decision are informed first and have a chance to comment.
- Minutes will be taken at every council meeting and any actions to be taken and every decision made will be carefully written down.
- The council will invite a wide range of people to meetings to help the councillors make the best decisions.

- The chairperson is in charge of the School Council meeting and has the right to silence people or remove them from the meeting if they are behaving badly.
- The link teacher and/or head teacher will have the right to prevent the School Council discussing any issues that s/he believes the council do not have the right to discuss or the power to do anything about.
- The link teacher and/or head teacher will have the right to prevent the School Council making a decision that s/he considers is not the responsibility of the council or within its powers to decide.

Promoting the School Council: giving the school community a voice

- Photographs of all School Council Representatives will be displayed outside each classroom.
- The work of the School Council will be advertised on the School Website.
- There will be a School Council suggestion box in each classroom for children to make comments to their council.
- There will be a suggestion box near the front entrance of the school for anyone, including parents and visitors to the school, to make comments to the School Councillors.

School council rights and responsibilities

- The council will have an account but can only spend money with the agreement of the head teacher.
- All members of the school will be informed of any decisions the council has taken.
- The council will have a responsibility to help the school become more environmentally friendly.
- The council will have the responsibility to think of ways to help the local community become a safer, healthier and more peaceful place to live in.
